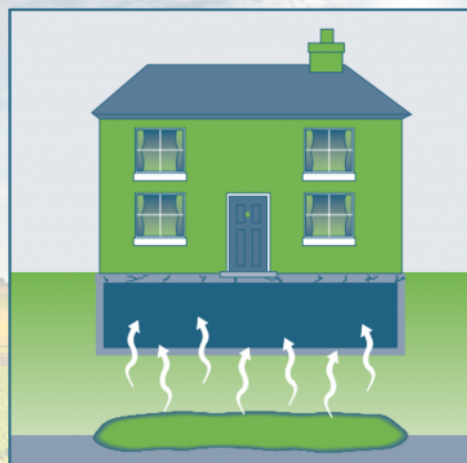

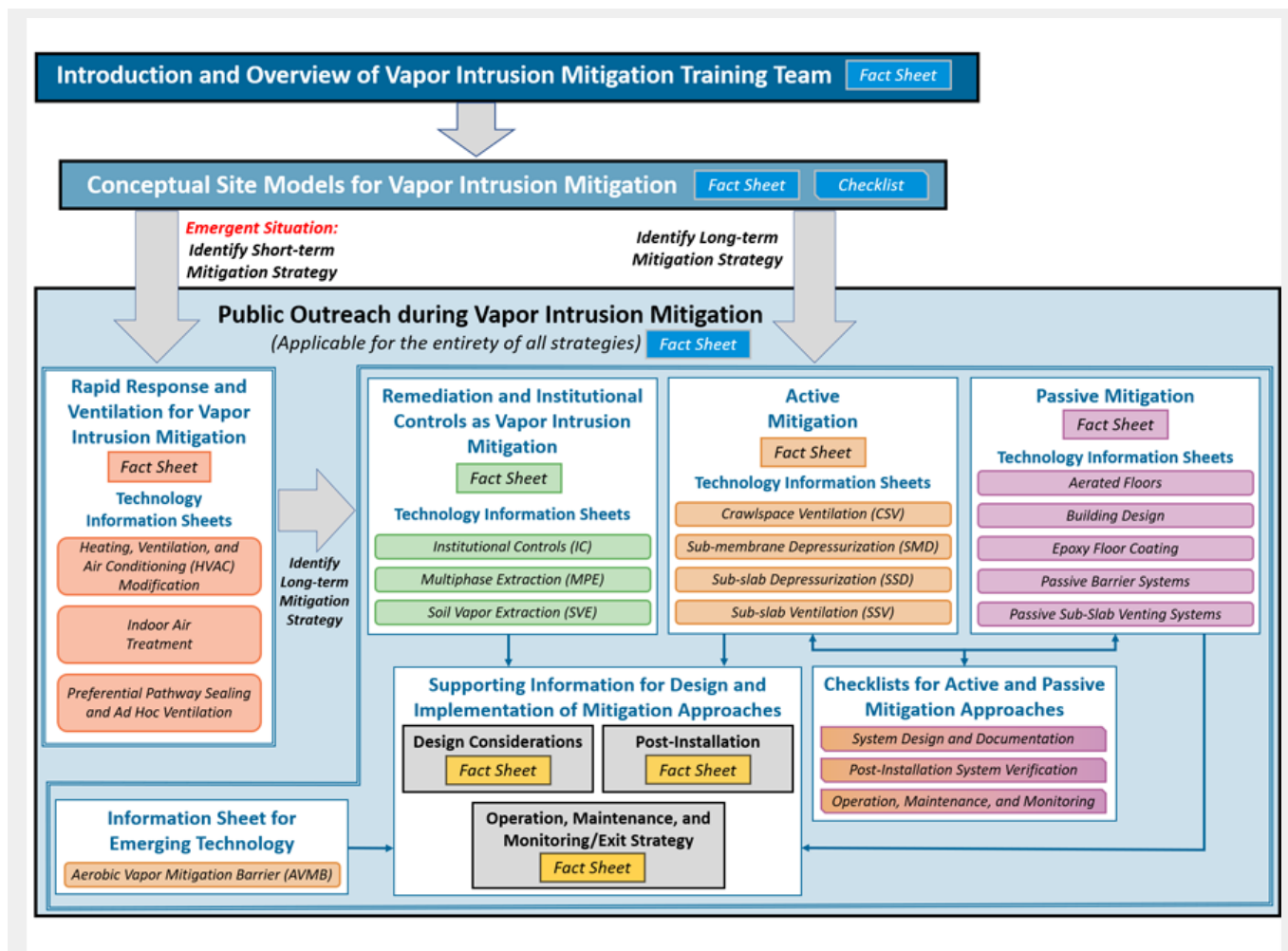

The document was developed by a team of over 200 environmental practitioners drawn from state and federal government, academia, industry, environmental consulting, and public interest groups. While every effort was made to keep the information accessible to a wide audience, it is assumed the reader has some basic technical background in chemistry, environmental sciences, risk assessment, and vapor intrusion.
